Application Instructions

Executive MBA Program

Please read and follow these instructions carefully. To be considered for admission into the Rutgers University Executive MBA Program, all forms and required documentation must be submitted along with the non-refundable application fee. Incomplete applications will be delayed in processing.

1. Application form and fee

Carefully complete, date, and sign the full application form and return it with a non-refundable application fee of S\$107, payable by check or electronic funds transfer. Checks should be made payable to "Rutgers Business School Asia Pacific Pte. Ltd." Do not send cash.

Application fee waiver: The application fee will be waived for all applicants who submit their complete application packet (including transcripts, letters of reference, and test scores) by the priority deadline.

2. Transcripts

Applicants must submit one transcript for each undergraduate and graduate institution attended. Official transcripts should be sent directly to the Rutgers Business School Asia Pacific office by each institution.

3. Letters of reference

Applicants are responsible for securing two letters of reference. The writer should submit the appraisal, written on business letterhead, directly to the Rutgers Business School Asia Pacific office in Singapore.

4. Test scores

GMAT/GRE: Most applicants must submit GMAT or GRE scores. For the GMAT, have Pearson Vue (pearsonvue.com) send your scores to code QK5-XT-51. This requirement is waived for applicants with a prior graduate degree (Masters, JD, PhD, etc.) from an accredited university. The EMBA Academic Director may also waive the requirement on a case-by-case basis for applicants with significant work experience or who are employed in unique industries or sectors that will add to the overall learning experience of the class.

TOEFL/IELTS: The EMBA program is conducted entirely in English and students must be proficient in both written and oral English. If your undergraduate degree was conducted in a language other than English, you may be required to provide proof of your English proficiency by submitting a TOEFL or IELTS score.

If you need help determining whether you are required to submit test scores, please contact the Rutgers Business School Asia Pacific office.

- Current resume or CV (1 copy)
- Application fee
